- The date of certification, and
- The name of the person certifying the document – printed clearly or evident in an official stamp with the contact details of the person or
- An official stamp indicating the status of the person certifying the document, ie Justice of the Peace, or Commissioner for Oaths or
- If a lawyer certifies documents, then the lawyers name must be indicated not just the law firm.
- Copies of **passports**, **academic transcripts**, and **IELTS report**, must be certified within the last 3 months by an authorised person if within Australia, or by Australian Embassy if overseas.
